FUND MANAGER'S REVIEW

During the period in review US Treasury yields saw continued with yields levels heading north reinforced by continued Fed hike expectations. Market players continue to price in prospects of a Fed December hike as recent US data anchored by strong job data, lower unemployment levels and stable inflation outlook nearing the Fed's target of 2.0% reinforces the view for US policymakers to resume with another possible 25 bps adjustment to FFR at the next Federal Open Market Committee (FOMC) meeting scheduled on 20th December.

Local govvnies continued to weaken in October, moving in tandem with the fall of the ringgit and the surge in UST yields. The pressure came primarily from the prospect of higher US interest rates given the slew of positive US economic data releases, although Malaysia's fiscal concerns also contributed.

The Fund intends to invest between 70% to 98% of its NAV in Sukuk.

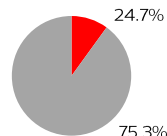
