FUND MANAGER'S REVIEW

During the period in review, the Federal Reserve's Federal Open Market Committee (FOMC) decided to leave its short-term interest rates unchanged, keeping the target range of the Fed funds rate at 2.00%- 2.25%. That is the highest it has been since the great recession a decade ago. The FOMC said it expects to continue gradually raising rates as the economy expands, noting that inflation remains tame. US Treasuries displayed resilience as the curve witnessed bullflattening-bias save for the long-bond which stayed flat. Overall benchmark yields ended 0-3bps lower amid volatile equities and recent slump in oil prices.

Local govvnies saw a recovery in interest w-o-w as overall benchmark yields ended mixed; with yields lower further out on the curve which saw a flattening-bias overall which is similar to the UST curve.

The Fund intends to invest between 70% to 98% of its NAV in Sukuk.

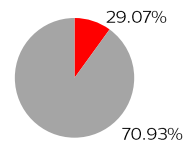
