FUND MANAGER'S REVIEW

During the period in review, the Federal Reserve's Federal Open Market Committee (FOMC) decided to leave its short-term interest rates unchanged, keeping the target range of the Fed funds rate at 2.00%- 2.25%. That is the highest it has been since the great recession a decade ago. The FOMC said it expects to continue gradually raising rates as the economy expands, noting that inflation remains tame. US Treasuries displayed resilience as the curve witnessed bullflattening-bias save for the long-bond which stayed flat. Overall benchmark yields ended 0-3bps lower amid volatile equities and recent slump in oil prices.

Local govies continued to weaken in October, moving in tandem with the fall of the ringgit and the surge in UST yields. The pressure came primarily from the prospect of higher US interest rates given the slew of positive US economic data releases, although Malaysia's fiscal concerns also contributed.

The Fund intends to invest between 70% to 98% of its NAV in Sukuk.

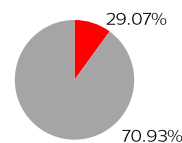
