FUND MANAGER'S REVIEW

During the period in review, the Fed hiked the Fed Fund Rate (FFR) by 25bps to 2.25-2.50% range but the policy statement and economic projections were not as hawkish. US government bonds rallied and stocks fell as markets placed worries on future rate hikes impending on growth prospects.

Ringgit Sukuks closed firm, sentiment buoyed early on after overnight UST gains. This was despite Federal Open Market Committee (FOMC) coming up but that meant players were repositioning ahead of the risk event. Also supporting sentiment was release of subdued inflation data. Headline inflation eased to 0.2% yoy in Nov as a result of fuel deflation.

The Fund intends to invest between 70% to 98% of its NAV in Sukuk.

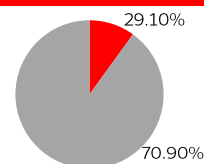
